- 1 All disturbed areas within the right of way shall be top-soiled, seeded and mulched to match existing areas per current MDOT standards and specifications.
- 2 Please see attached special conditions, traffic control, standard details, approved plans, etc.
- 3 Advance notice shall be submitted in CPS and approved prior to starting any work within the MDOT right of way. Similarly, a completion notice shall be submitted once work is done to ensure final inspection and closure of the permit accordingly.
- 4 72 hours prior to starting work in the MDOT ROW the applicant/contractor shall contact the MDOT Inspector, Eric O'Neal 248-234-3914, for coordination and confirmation prior to starting any work; including the attached Lane Closure Notification Form.
