Gentlemen-The members of your body have undoub edly noticed the presentment made last week by a Grand Jury of Wayne County relative to the condition of affairs at the House of Correction.

That paper charges that the food furnished there is insufficient and unwholesome, and that modes of punishment, especially of women, both dangerous

and cruel, are allowed The House of Correction has been an object of your anxious interest and care It is within the special province of one of your standing committees. For greater security it has a Board of Inspectors has always, in all its departments been freely opened to visits from our citizens and the public,

It therefore justly increases the surprise, that, if such gross abuses exist they should be first brought to light by the action of a body so accidental, and now so nearly obsolete with us, as a Grand Jury. Still we think the duty before na plain. These charges must be promptly and carefully inquired into. If such abuses exist, they should be condemned and redressed.

A searching and thorough investigation should, in our judgment, be made into the whole condition of the prison. And we therefore respectfully recommend that, at the earliest practicable period, you take such measures as are best adapted to accomplish the desired end. It is proper for us to add that the Superintendent, Mr Brockway, promptly applied to the B ard of Inspectors for such investigation.
