"swine," however young, was one dollar, and by the amendatory ordinance of May, 14, 1864, this fee was reduced to twenty-five cents for "sucking pigs." By the ordinances as they now stand. however, the Pound Master is required to demand of the owner when he comes to redeem impounded coming two dollars for the impounding fee, and one of the owner when he comes to redeem impounded swine two dollars for the impounding fee, and one dollar in all cases for one day's keeping. Under these provisions of the ordinances the Pound Master of the Western District, as he was bound to do, has demanded and received of Mrs. Julia Hill two dollars each for four "sucking pigs." Mrs. Hill says she is poor and asks if she cannot have some relief in the premises. Impounding of "sucking pigs" is twenty-five cents while the redemption of them is, as the ordinances now stand, two dollars, and \$1 per day for keeping the tame as full grown swine. I think the ordinance should be amended in this respect, and would respectfully recommend that four dollars be repaid to Mrs. Hill.

To the Honorable the Common Council:

GENTLEMEN—The Committee on Ways and Means, to whom was referred the communication of the Controller of the 11th instant, tendering his resignation of that office on account of the insecure state of his health, would respectfully report:
That we have waited on him for the purpose of learning his final decision in the matter, and have to inform your honorable body that he still adheres to the determination to retire from the cares and arduous duties of the office, believing that he could not much longer continue to perform those duties without serious detriment to his health. Your committee sincerely regret the cause which renders it necessary for him to resign an office, the duties of which he has discharged for nearly four years with so much credit to himself and fidelity to the public interests.
