SECTION 1. That section 12, of chapter 2, revised ordinances, 1863, shall be so amended, as to read as

"Section 12. The City Counselor shall be appointed "Section 12. The City Counselor shall be appointed by the Common Council, and shall hold his office for the term of three years; he shall be a practicing attorney of the Supreme Court of this State, and of good standing as such; he shall keep an office in some public and convenient place in the City of Detroit, and shall, before entering on the duties of his office, give an official bond, duly conditioned, 1st, that he will not, while holding the office of Counselor for the City of Detroit, accept of any fee, retainer or reward of any kind from other parties for professional services to be rendered to them, except upon the express condition that such services shall not in any way conflict with his duties to the city, as its counselor; and, 2d, with his duties to the city, as its counselor; and, 2d, for the performance of all his duties, as prescribed by the charter and ordinances of the city, in the penal sum of two thousand dollars."
