Gentlemen—At a meeting of the City Sinking Fund Commissioners held May 2, 1900, the following Commissioners Were present, viz: Commissioners May-bury, Blades, Coots, Marx, Welbel, Houghton and Thompson.

The following resolution was offered by Commissioner Maybury:

Whereas, In the sale of bonds issued by the city for the use of the Park and Boulevard Commission, in the erection of an Aquarium and Horticultural building, there was realized a premium of \$9,811 beyond the par value of the stock issued, viz: \$150,000 par value, and

Whereas, The provisions of the act under which the issue of the bonds was authorized, provide that a sum not to exceed \$150,000 shall pass into the control of the Park and Boulevard Commission, for the purposes indicated in the act. The excess above referred to is resultant upon the city's high credit; and in the opinion of this committee of the Sinking Fund it belongs wholly to the city; and,
