Gentlemen—The communication of his Honor, the Mayor, to your honorable body at its meeting, in regard to the use of the city's track in Third avenue, between Grand River and Ledyard, by the Detroit & Northwestern Railway Co., contains the gratuitous statement that "the Board of Public Works has heretofore assumed to give franchises in the streets of the city." The Board hastens to reassure His Honor and the Common Council. They have done nothing of the kind. The present Board of Public Works has simply followed the system which has been in vogue for years past, and never before been questioned, so far as they are aware, of granting permits for crossovers, turnouts, switches. curves, etc., on the advice of the Corporation Counsel, their only competent legal adviser, that it was their right and duty to grant them, and that the companies were entitled to them under their original franchises granted by the Common Council. After the hands of the railway company had been tied by an injunction at the instance of your honorable body, and was in the hands of the Circuit Court for determination, the Board of Public Works, which is composed of law-abiding citizens, thought it wise to await the court's decision and kept its hands off the property of the company. This old straw has been thrashed over so often that the Board supposed its position was well understood by every citizen who reads, and the statement of the chief executive to your honorable body came as a painful surprise.
