Gentlemen: Access to Newark street from alley in block east of Twentieth street was cut off because of lowering of grade of Newark street and, so that teams in this alley would be given room to turn around, the Common Council on November 23, 1909, instructed the Corporation Counsel to file in the Recorder's Court a petition looking to the condemna-

tion of land required to widen alley at its northerly end.

Incident to the settlement of damages sustained by the premises at southeast corner of Twentieth and Newark streets because of grade separation, the land required for this alley widening was acquired by the city; the condemnation proceedings which we instituted should, consequently, be withdrawn.

I respectfully request authority to withdraw petition in these proceedings.
