To the Honorable the Common Council: Gentlemen—Referring to the new Ordinance defining Parks and Boulevards, and the restrictions of traffic thereon,—it is noted that no trucks will be allowed to travel on any of the new boulevards, etc., except that Post Office trucks will be permitted on Second and Lafayette boulevards. Second and Lafayette boulevards.

The limited use of all the thorough-fares to be included under the new Ordinance as boulevards is quite necessary in the maintainance of the Post Office collection, delivery, station and depot schedules, and it is therefore requested that the exception in favor of the use by Post Office trucks be extended to embrace all thoroughfares designated Boulevards under said Ordinance.

Such traffic will not be scheduled to travel Boulevards except where necessary, but it is desired that the use of the Boulevards by Post Office trucks be mentioned in the Ordinance before adoption, so as to avoid future confusion with the Police Department in the enforcing of its provisions.
