Gentlemen: At the present time the
D. P. W. is garaging a great many of
its trucks at the City Asphalt Plant,
Western Yards, and Sewer Department Sheds, due to the fact that its
garage at Sixth and Abbott streets is
greatly overtaxed, besides they added
over 40 trucks to their equipment this year.

The Board of Health, Department of Buildings & Safety Engineering, Public Welfare, Recreation, House of Correction, Public Library, Civil Service, City Treasurer, Purchases and Supplies and Railway Commission combined, operate 77 automobiles and trucks, but at the present time have no garage facilities

facilities. The Deepartment of Motor Transportation desires to pool these cars and operate and maintain them from one central garage. There is a garage now vacant at 672 Fort street, owned by Mr. J. A. Mercier, with a storage capacity of 75 cars, equipped with gasoline and oil pumps and all modern conveniences. The rental charge is \$800 per month, including heat and light.

This Department desires to rent this garage and hire the necessary help to maintain the cars in proper condition and recommends the creating of a fund known as the "Municipal Garage known as the "Municipal Garage Fund."
