At the intersection of Woodside Avenue, Northfield Avenue angles to the west and has been renumbered as an east and west street, causing a duplication of the numbers. We would therefore recommend that the name of Northfield Avenue from Woodside to Central be changed to Westfield Avenue.

To the Honorable the Common Council:

Gentlemen—Acting upon the petitions of Lawrence Clay et al. (5586) and J. D. Brennan (6186) to open Central Ave. from Warren Ave. to Vernor, referred to this Commission by your Honorable Body, we would advise that a careful study of this matter has been made, not only for the opening, as petitioned, but also with a view to widening the entire street and making it an important north and south thoroughfare. We find that the widening of the entire street would not warrant the cost, inasmuch as the street is very narrow in certain sections, and the lots very short.

We wrote to the petitioners asking that they appear for a hearing and at the hearing held in this office the plan for the opening was approved.

Inasmuch as the opening will pro-

vide an outlet for the people in the vicinity, we would recommend that Central Avenue be opened from Warren Avenue to Vernor to a width of sixty feet. All of the above as outlined in yellow on attached blueprint, Plan No. 305-3.
