As the amount in our budget for labor, (2B Account), was cut 15 per cent, it was necessary to reduce wages 15 per cent. The school engineers feel that this is an injustice to them and, I understand, have petitioned your Honorable Body to establish the old rates. If the wages of the engineers and school people are to be raised, the wages of the carpenters, laborers and other people in the Department which were cut 15 per cent, should also be restored. This will cost approximately \$3,000.
