Resolved, That the warranty deed of the University of Detroit to the City of Detroit, of all those certain pieces or parcels of land, situate in the City of Detroit and described as follows: "Beginning at the northwest corner of lot 1 of Marshall Park subdivision of the southwest quarter of the northwest quarter of Section 15, Town. 1 South, Range 11 east, as recorded in liber. 33 of plats., page 54, Wayne County Records; thence along the north line of said subdivision north 89 degrees 34 minutes east 1,008 feet to

a point on the east line of the alley extended northerly first west of vacated Dexter avenue (formerly Glenn avenue); thence along said line of alley north 50 feet to a point on a line 50 feet north of and parallel to the north line of said Marshall Park subdivision; thence along said line south 89 degrees 34 minutes west 1,008 feet to a point on the east line of Livernois avenue; thence along said line south 50 feet to the place of beginning, being a part of N. That the warranty deed of Burt Eddy Taylor, et al. to the City of Detroit, of all that certain piece or parcel of land situated in the City of Detroit and described as follows: "All that part of lot 43 of Westlawn subdivision No. 2 of part of the west half of the southwest quarter of section 28, T. 1 S., R. 11 E., as recorded in liber. 32 of plats., page 11, Wayne County Records, described as follows: Beginning at the southwest corner of lot 42 of above mentioned subdivision, thence along the west line of said lot north 1 degree 4 minutes west 1,005.38 feet to a point on the west line of said lot 43, thence along said line south 0 degree, 1 minute east 995.21 feet to a point on the north line of Grand River avenue, thence along said line south 60 degrees 58 minutes east 20.60 feet to the place of beginning," be and the same is hereby accepted and approved; and further
