Resolved, That it be and is hereby declared by the Common Council of the City of Detroit, necessary to make in said City the following described improvement and that the same is for the use or benefit of the public, viz.:

Opening Linwood avenue from alley first north of Virginia Park to Fenkell avenue, where not already opened, and widening said avenue between said points where already opened as a public street and highway.

That they deem it necessary to take private property for the purpose of making such improvement, which said property is situated in said City of Detroit and is bounded and described as follows:

To the Honorable the Common Council:

Gentlemen—In the last three years great increases have been made by the Assessors in the number of personal property assessments, thus adding very much to the work of collection in the Treasurer's office.

At this time there remains unpaid on personal taxes for 1920, an amount in excess of \$200,000, and for 1921, approximately \$750,000.

Bills for these taxes have been mailed at different intervals and payments are coming in all the time, but it is apparent to me that unless all the people who owe personal taxes for the two years mentioned can be called upon personally, the C'ty will not otherwise collect a heavy percentage of this money. For the past three months, I have had four men at work on this job, and while they have brought in a great many thousands of dollars, we are not catching up as fast as we should.

I therefore request at this time authority to hire ten personal tax collectors for a period of two months, and recommend that your Honorable Body provide for the payment of the services of these men from the contingent fund.
