ceed with the construction of a power ceed with the construction of a power plant, this Department requests that an apprepriation in the amount of \$4,000,000 be provided for the purpose of erecting the power station buildings, laying the necessary railroad connections, and awarding contracts for that part of the power apparatus which will require from six to eight months for fabrication after the award of the contract.

months for fabrication after the award of the contract.

Next year, an appropriation in approximately a like amount will permit the completion of the power plant and installation of the required conduits and cables, which should enable this Department to distribute the power required for the City of Detroit by July 1, 1925. In the meantime it will be necessary to secure such power under as favorable contracts as posunder as favorable contracts as possible.

To the Honorable the Common Council:

Gentlemen-Acting upon the resolu-Gentlemen—Acting upon the resolu-tion of your Honorable Body under date of February 7, 1922 (J. C. C. 203) the City Plan Commission is pleased to report that based upon the various investigations made by it, a prelim-inary draft of a zoning ordinance has been prepared. Considerable time was spent in conference with various or-ganizations in the city such as comganizations in the city, such as commercial, manufacturing, real estate and financial interests, and in considering petitions which have been received relative to the proposed ordinance, in order that the ordinance might be perfected in every detail. We have called in several men from different cities who are experienced in zoning work to assist us and the proposed or-dinance has been redrafted to meet conditions as developed from such conferences and studies.

To facilitate the public hearings and discussions upon the ordinance and maps, the Commission suggests that the ordinance be printed in pamphlet form and an estimate has been received of two thousand dollars. We therefore request that the Controller be directed to advance from available funds and place to our credit the sum of two thousand dollars, so that the tentative draft of the ordinance and maps may be printed for general circulation.
