To the Honorable the Common Council: Gentlemen—The Civil Service Commission begs leave to submit the following as its report for the calendar year of 1921:

You will note that no innovations or additional activities were taken by this Commission for the year just past. Some of the methods employed were amplified, and the volume of work is far in excess of any year in the history of this Commission.

Eighty meetings were held; Sixtytwo Hundred and Forty-seven (6,247) applications were received; One Hundred and Thirty-nine (139) examinations were given; Fifteen Hundred and Seventy-six (1,576) eligibles were certified to positions, of which Twelve Hundred and Seventy-six (1,276) were appointed, and Three Hundred (300) declined positions of which they were notified. Two Hundred and One (201) resignations were received; Six Hundred and Twenty-five (625) discharges. Eleven (11) protests were heard by the Commission, Nine (9) of which were dismissed and the discharge af-
