## From the Department of Water Supply.

the Common the Honorable Council:

The dredging operations carried on by the Govern-Gentlemen: ment in widening and deepening the River Rouge, made necessary the removal of the water pipe crossing the River Rouge to Oakwood near Fort street, West. Previous to the annexation of Oakwood by the City, the officials of that village were fully informed of the progress of the work of improving the River Rouge and the importance of constructing a new water pipe, but no work was done to that end until after the water system in Oakwood was taken over by this Department.

On December 26, 1922, this Board signed a contract with Greiling Bros. Co., Contractors. Green Bay, Wisc., to lay a 24 inch water pipe crossing the river at this point. The pipe has been laid, but to date the Contractors have failed to make it tight, and although the loss by leakage is not great, this Board proposes to hold the Contractors to the agreement and insist upon a first class job. The terms of the contract provide that this Board may take over the work upon ten days' notice, and this notice was given Sept. 4. Unless Greiling Bros. proceed with this work by, or before the expiration of the ten days' mentioned, this Board will undertake the work either by contract or otherwise. Water conditions in Oak-Wood and Lincoln Park are very unsatisfactory at present, and the Board considers the completion of this line an emergency requirement.
