To the Honorable the Common Council:

Gentlemen—We are enclosing, herewith, the petition of the Ford Reserve Realty Company in which they offer to dedicate to the city 3 feet of land on both sides of Kentucky avenue at Fenkell running back to the alley, 3 feet on the west side of Indiana, 3 feet on the east side of Wisconsin and 3 feet on both sides of Ohio avenue provided a special width of pavement is laid.

The Commission is of the opinion that a wide pavement is desirable on these streets at Fennell avenue because of the business frontage facing the street. If the pavement is widened it will provide additional parking facilities.

Inasmuch as the first cost of pavement must be borne by abutting property owners, we recommend that the offer of the Ford Reserve Realty Company be accepted.
