General order for Monday.

From the City Plan Commission.
To the Honorable the Common Council:

Gentlemen—The City Plan Commission has prepared a revised plan for the opening and widening of McGraw avenue from Martin avenue to Michigan avenue. The original plan submitted to your Honorable Body on June 21, 1919, and approved on September 30, 1919, (J.C.C. 1529) contemplated the connection of McGraw avenue at Michigan with what was then known as Dewey avenue south of Michigan. Since such approval, Dewey avenue has been vacated.

We are informed by the General Motors Corporation that they will co-operate with the City in providing land on the north side of Saxon avenue (Ford Road) between Western and Wyoming avenues to make Saxon avenue an eighty-sixfoot (86-ft.) street; also the land for the opening of Wyoming between Saxon and Michigan. The Village of Springwells will provide sufficient land to make Wyoming an eighty-six-foot street to connect with Edwin street (86-ft.) south of Michigan.

It is the opinion of the Commission that such revised plan will provide even a better opening into Michigan than the original plan approved by your Honorable Body. It will also provide for the much needed opening of Wyoming avenue. We therefore recommend that the action of your Honorable Body ordering the Corporation Counsel to prepare the necessary resolution for the opening and widening of McGraw avenue from Martin to Michigan be rescinded insofar as that portion between Western and Michigan avenue is concerned and also recommend that the revised plan, submitted herewith, be approved.
