Gentlemen-Attached to this communication I am submitting test reports on three samples of car oil for the Detroit Street Railway, Your Honorable Body requested Your Honorable Body requested comparative tests to determine, as Your Honorable as possible, the relative value of the samples submitted.

The tests on samples submitted discloses that the brand selected did the specifications not meet nished the Department of Purchases and Supplies. The tests on the other brands submitted raise a doubt as to whether or not the higher-priced oil would give better service.

There is some doubt as to whether or not an exact compliance with the specifications would give a superior lubricant.

I am informed that the City buys yearly, about \$38,000.00 worth of lubricating oils. It is my opinion that a desirable economy can be obtained if correct methods are used in testing oils before and after purchase. This can be effected at reasonable cost and the tests made under conditions comparable with the actual use to which the oil will be subjected as to temperature, unit bearing loads and velocities. I recommend this for your consideration.
