## From the Department of Buildings and Safety Engineering

the Honorable the Common Council:

Gentlemen-The requirements of our building code covering clay or shale tile and concrete blocks tile are rather vague and indefinite. Also they work considerable hardship both on the manufacturers and builders because of several unsatisfactory features therein.

In order to adjust this matter I have held consultations with both manufacturers and users of these products and have given the matter careful study, with the result that I have prepared two bulletins which I intend to circulate among interested parties, which will act as modifications of or amendments
