Gentlemen—At its June 3rd, 1925, the Police Pension Committee acted favorably on petition of Mrs. Grace E. widow of the late Patrolman Alonzo Bennett, Bennett, who died on April 2nd, 1925, as a result of injuries sustained March 23rd, 1925, when he was struck by an automobile and knocked from his motorcycle while chasing a speeder on St. Jean Avenue.

The Committee granted petition for payment of a pension of \$100 per month to the widow and \$20.00 per month to a minor child from and after April the 3rd, 1925, the late patrolman's salary having been paid up to and including April the 2nd of this year.
