Gentlemen—This condemned the necessary property to widen Metzger Avenue feet to line up with Metzger Avenue in the City of Detroit, which is a continuation of Ford Highway, except the center strip which is 25 feet wide and is now owned by the City of Detroit and occupied by the tracks of the D. S. R.

Sometime ago we took up question of paving this street with the Engineering Department of your city and it was understood at that time that it would be paved in the same manner as it is now paved west of Twelfth Street, where there are two 30-foot strips of paving with the center strip 25 feet wide, occupied by the street car tracks. More recently I received a photostat indicating the width of the paving which your City finally determined to lay on this street, as two strips of paving 22 feet wide with an unpaved strip in the center 17 feet wide. In view of the fact that this ity does not own the center 25-foot strip it will be impossible for us to place the paving at this width, even though we were granted permission by the City of Detroit to occupy a part of this 25-foot strip as it would be impossible for us to assess to the abutting property, pavement laid on privately owned property.

I have been instructed by Mayor Gittins to suggest that you either reconsider the width and location of the paving on this street between Twelfth Street and our west city limits, or that you consider the question of dedicating this 25 foot strip, now occupied by the D. S. R., for street purposes. I am attaching hereto a blue print showing the general situation.

I would urge your early consideration of this matter as this city is willing and anxious to pave the part of the street in Highland Park this year, which will provide a direct connection between the Ford Highway and Hamilton Avenue.
