Hospital due to some extent to the addition of the new building now under construction which has increased the work of the present incumbent and also the necessity of the appointment of an assistant superintendent, the Public Welfare Commission would respectfully request that your Honorable Body grant permission to change the title of Office Manager to Assistant Su-perintendent and that the salary be increased from \$2,500 to \$4,000 per annum.

This change will not entail any additional appropriation as there will be sufficient money in the salary fund to take care of the in-

creased compensation.
