From the City Plan Commission

October 23, 1925.

To the Honorable, the Common Council:

Gentlemen—As requested by your Honorable Body, the City Plan Commission has made a study of the street situation in the district lying north of Schoolcraft avenue, and east of Wyoming avenue in order that we might determine whether or not Greenlawn avenue north of Schoolcraft avenue will be extended across the railroad.

A plan for this district was made by this Department several years ago, and after further considering the matter, we have determined that it will not be necessary to extend Greenlawn avenue across the railroad as Prairie avenue, Turner-Cloverdale and Northlawn avenues are the main streets which should be carried across the Pennsylvania Railroad right-of-way. Greenlawn

avenue is just one block west of Cloverdale avenue.

In view of the fact that buildings are being constructed in the vicinity of Prairie avenue it might be advisable for the City to institute proceedings immediately to open this street.

Gentlemen—I respectfully report to your honorable body that a Jury duly impanelled in the Recorder's Court, in the matter of widening, extending and opening of streets so that Dix Avenue and Waterloo Street may be connected and thereby provide to crosstown traffic a direct route whereupon crowded downtown streets may be avoided and relieved as a public street and highway. Rendered a verdict in favor of said opening, Monday, Dec. 22nd, 1924, which was amended and confirmed by the Court Friday, November 6th, 1925.

In accordance with the statute, I herewith transmit a certified copy of said verdict as amended and of the judgment of confirmation as to Parcel No. 16.
