Gentlemen-The City Plan Commission has considered the petition Charles C. Kellog, Postmaster, (2204), referred to us by your Honorable Body, requesting that the name of Oakman Avenue be changed to Wilson Avenue, and requesting further that Oakman Boulevard be numbered in conformity with the plan of numbering on the Grand Boulevard.

Since the Ford Highway was changed to Oakman Boulevard there has been a great deal of confusion in the delivery of mail and parcels, and this is augmented by the fact that what is properly Oakman Avenue is still called Oakman Boulevard. We therefore have two streets in the City entirely disconnected using the name of Oakman Boule-This is a situation which must be corrected.

In view of the fact that Oakman Avenue from Webb to Pilgrim Avenue is a continuation of Wilson Avenue, the City Plan Commission recommends that it be changed to Wilson Avenue in accordance with the petition of Mr. Kellogg.

We are returning, herewith, the petition of Northern Progressive Business Men's Association protesting against the changing of the name of Oakman Avenue, and asking that they be granted a hearing. The City Plan Commission recommends, that this hearing be given to the Association.

Commission that the suggestion of the Postmaster should also be carried out with reference to the numbering of Oakman Boulevard.
