at the present time recommend that this site, or any particular site, be acquired with the funds left for that purpose.

Hon. Richard W. Reading, City Clerk, Detroit, Michigan.

Dear Sir—I beg to acknowledge receipt of yours of the 19th, together with copy of a resolution adopted by the Common Council of the City of Detroit, May 18th, relative to the proposed sale of Fort Wayne and requesting information as to the price at which the Federal Government will transfer this property to the City of Detroit. It appears that this resolution was sent to both representatives from Detroit and to the two Senators from Michigan.

There is a bill pending now authorizing the sale of these forts to be abandoned to the states or the municipalities. The War Department will value these properties and give plenty of time, I am informed, to the municipalities to purchase them. I am also informed, however, that nothing will be done until the bill known as H. R. 12270 has been passed.

In any event I will be very glad to keep in touch with the situation and secure the information for the Common Council at the earliest p's-sible date.
