Whereas, This honorable body has had under consideration petition 2086 filed by Oscar C. Robinson, et al., requesting a quit claim deed for a strip of land on the south side of Jefferson ave. between Lenox and Drexel aves, which strip lies between the south line of the street and the buildings now erected; and

Whereas, It appears from a reading of previous records of this honorable body that some years ago an effort was made to straighten out and make uniform the building line on East Jefferson ave., between Dickerson and Piper aves., and to secure deeds to the city for that purpose;

Whereas, This plan was not carried out except in the block between Drexel and Coplin aves., for which deeds were secured to the City for strips of land in said block; and

Whereas, As a matter of fact buildings have been erected to the new building line and in order to insure the maintenance of said building line, it is necessary to condemn the properties dedicated; and

Whereas, The Common Council did heretofore recommend that the Corporation Counsel be instructed to prepare the proper resolution for the condemnation of the strips of land lying between the south line of East Jefferson ave. and the buildings now erected, between Dickerson Drexel aves., and adjoining lots 1, 2 and 3 of Block D of Jefferson Park Subdivision; and

Whereas, The said Oscar C. Robinson, et al., are desirous of dedicating the strip owned by them and described as part of lots 1 and 2 of Block B of Jefferson Park Subdivision of the Jefferson Realty Company in the City of Detroit as recorded in Liber 26, page 93 of Plats of Wayne County Registry, lying north of the building on said premises; and

Whereas, Mr. Robinson's predecessors in title had under a previous resolution of this rendered a deed of said strip which deed was lost and never recorded, and desires to clear up his title and make a retender of a quit claim deed of said strip.

Therefore Be It Resolved, That the Therefore be to its proper officials does hereby quit claim back to the said Oscar C. Robinson, et al., the said strip heretofore quit-claimed by said strip herecorded by his predecessor in title but which deed was lost and never recorded, does hereby accept from the said and does hereby accept from the said oscar C.
