seven feet of Woodward property, which we agree to dedicate to the City of Detroit, without charge, would probably be somewhere betweed \$50,000 and \$100,000.

We have invested millions of dollars to erect a building which would be in keeping and in harmony with the character of Detroit's beautiful Art Center, and if your Commission and the Common Council will agree to the compromise above set forth, it will not only enable us to keep our magnificent building intact, but will also save the City a goodly fraction of a million dollars, in the cost of widening Woodward Avenue, and at the same time it will accomplish the same purpose and utility and advantage of the widening without jeopardizing the "Verdict of Necessity" because unnecessary expenditure, which could be avoided by a slight change in the plan.

This will also enable us to comply fully with the laws of the State of Michigan and the rulings of the Department of Insurance.

We therefore respectfully petition your Commission and the Common Council to accept this compromise and instruct the City Engineer to make the necessary survey of the property :o be dedicated, and prepare the necessary deed for our signature and execution.
