Gentlemen-The Board of Water Commissioners is in receipt of a communication dated November 29, 1926, from Fred L. Woodworth, Collector of Internal Revenue. The collector informs this Department that by a decision rendered by the Commissioner of Internal Revenue at Washington, D. Gentlemen - Referring to communication of your Honorable Body under date of December 1st, will say that in 1913 a city hospital was established by the Board of Pcor Commissioners and named by the Commissioners, the Receiving Hospital, as this name at that time represented the full scope of the institution.

Since that time, however, the scope has greatly enlarged. Aside from the emergency service, the

general and special surgical cases are now cared for. Recently a ver. bal request was made by Commis. sioner Vaughn, of the Department of Health, that the Commissioner take over the obstetrical work now being handled at the Herman Kiefer

About two hundred and fifty cases among the city poor are now being treated at the various private hospitals in the city, which will be taken over at an early date by the City Hospital where they can be handled more economically.

We have written permission from Mr. Henry Ford, under date of June 23, 1926, whereby the Public Welfare Commission is given legal right to use the corporate name of the Detroit General Hospital.

In our desire to further the interests of Detroit from a medical and surgical point of view, and also on account of promised private contributions for much needed research work, we, therefore, respectfully petition your Honorable Body to approve the action of this Commission in re-naming the Receiving Hospital, the Detroit General Hospital.
