From the Board of County Road Commissioners

To the Mayor, the Common Council, the City Clerk, and the Commissioner of Public Works of the City of Detroit, Wayne County, Michigan:

Sirs-You are hereby notified that the Board of County Road Commissioners for the County of Wayne, Michigan, did, at a meeting of said Board, held on Friday, October 28, 1927, decide and determine that a section of a certain road described in the minutes of said Board should be no longer a county road under the jurisdiction of said Board of County Road Commissioners for the County of Wayne, State of Michigan. "In the matter of relinquishing jurisdiction over a certain section of the road hereinafter described, it was moved by Commissioner Hines, supported by Commissioner Haggerty, that the Board of County Road Commissioners of the County of Wayne, State of Michigan, relinquish its jurisdiction over the following described section of road: Beginning at the intersection of Harper Avenue and Gratiot Avenue in the City of Detroit and proceeding thence northeasterly along Gratiot Avenue for a distance of 4.37 miles to the northerly City Limits, or the Base Line Road.

"Vote on the motion resulted as follows: Ayes, Commissioners Butler,, Hines and Haggerty. Nays, none. Whereupon it was ordered that the above described section of road be no longer a county road under the jurisdiction of the Board of County Road Commissioners, of the County of Wayne, State of Michigan."
