Resolved, that warranty deed of The Lincoln Motor Co. to the City of Detroit covering property dedicated for street purposes described as "All of Lots 176, 177 and part of Lots 178, 179 and 180 of Thos. V. Wreford's Subdivision of Lots north of Holden Avenue of the Subdivision of the north part of the E. half of Private Claim 574 as recorded in Liber 9 page 78 of Plats of Wayne County Records, more particularly described as follows: "Beginning at the intersection of the easterly line of Livernois Avenue, 66 ft. wide, with the southerly line of Joy Road (formerly Bonaparte Avenue) as opened; thence along said southerly line of Joy Road (formerly Bonaparte Avenue) N. 62 deg. 02 min. E. 72.62 ft. to a point on the westerly line of Hammond Avenue, 50 ft. wide; thence along said line S. 27 deg. 26 min. E. 60 ft. to a point; thence along a line S. 62 deg. 02 min. W. 72.48 ft. to a point; thence along a line S. 01 deg. 27 min. E. 68.07 ft. to a point on the westerly line of Lot 180 of last mentioned Subdivision; thence along the westerly line of Lots 178, 179 and 180 of said subdivision N. 27 deg. 47 min. W. 59.99 ft. to a point on the easterly line of Livernois Ave. as now established; thence along said line N. 01 deg. 27 min. W. 68.38 ft. to the place of beginning.

Also the easterly part of Lots 168 to 175 both inclusive of last mentioned Subdivision described as follows: "Beginning at the intersection of the northeasterly line of Military Ave. with the easterly line of Livernois Ave. as now established, thence along said easterly line of Livernois Ave. N. 01 deg. 27 min. W. 215.45 ft. to a point; thence along the easterly line of Lot 175 of said subdivision S. 27 deg. 47 min. E. 60.78 ft. to a point; thence along a line S. 01 deg. 27 min. E. 215.69 ft. to a point on the northeasterly line of Military Avenue, 50 ft. wide; thence along said line N. 27 deg. 47 min. W. 61 ft. to the place of beginning."

Also the southerly 22.98 ft. of Lots 277 to 283 both inclusive of last mentioned subdivision, being measured on the east and west lines of said lots.

Also the southerly 22.98 ft. of Lots

187 to 190 both inclusive of Scripps Holden Ave. subdivision of Lot 2 of Plat B, of the subdivision of the Estate of John Strong, Private Claim 574 as recorded in Liber 19 Page 67 of Plats of Wayne County Records, being measured on the east and west lines of said lots.

Also the southerly 22.98 ft. of Lots 51 to 56 both inclusive of said Scripps Holden Ave. Subdivision being measured on the east and west lines of said lots.

Also all that part of Lot 50 of last mentioned subdivision described as follows: Beginning at the southeasterly corner of said Lot 50; thence along the southerly line of said Lot N. 88 deg. 10 min. W. 29 ft. to a point on the westerly line of said lot; thence along said line N. 27 deg. 59 min. W. 100 ft. to a point on the northerly line of said lot; thence along said line S. 88 deg. 10 min. E. 2.02 ft. to a point; thence along a line S. 27 deg. 59 min. E. 77.14 ft. to a point; thence along a line S. 88 deg. 10 min. E. 26.73 ft. to a point on the easterly line of said lot; thence along said line S. 27 deg. 39 min. E. 22.98 ft. to the place of beginning.

Also all of Lot 49 of last mentioned subdivision.

Also all that part of Private Claim 574 described as follows: Beginning at a point on the intersection of the southerly line of Tireman Avenue and the easterly line of Livernois Avenue, as now established; thence along the southerly line of Tireman Ave. as now established. S. 88 deg. 09 min. E. 41.42 ft. to a point; thence along a line S. 0 deg. 06 min. W. 56.48 ft. to a point; thence along a line S. 20 deg. 19 min. E. 70.30 ft. to a point on the easterly line of Livernois Avenue, as now established; thence along said line N. 27 deg. 59 min. W. 140.01 ft. to the point of beginning," be and the same is hereby accepted and the City Controller be and he is hereby authorized and directed to record said deed in the office of the Register of Deeds for Wayne County.
