Gentlemen-The City Engineer reports that a pumping station has been erected by Louis G. Palmer & Company at the corner of Piedmont and West Chicago Avenue. This station is now serving lateral sewers formerly constructed in Palmer Grove Park Subdivision.

On March 2nd, Louis G. Palmer & Company requested the City to take over and operate this pumping station. There are several homes al-ready constructed in the subdivision and many more proposed in the near

The equipment has been inspected by the City Engineer and found in first-class working condition.

Since the public health and safety of this community is dependent upon the proper operation of this pumping station. I respectfully recommend that your Honorable Body authorize me to enter into agreement with Louis G. Palmer & Company for the maintenance and operation of the existing pumping station located on lot No. 86 on the east side of Piedmont Avenue, north of West Chicago, in the Palmer Grove Park Subdivision. ## From the Department of Public Works

Gentlemen-In accordance with authority of the Committee of the Whole, given to the writer under date of February 1st, negotiations have been completed with the C. N. Ray Corporation, for the purchase of the necessary land for the widening of Livernois Avenue, immediately north of and adjoining the intersection of Toledo Avenue, and south of the railroad right-of-way, on the basis of \$1.25 per square foot. The land required for this improvement is described as follows:

"All that part of lots 1 and 2 of Welch's subdivision of the southerly part of Private Claim 574 as recorded in Liber 3, page 45 of Plats of Wayne County Records, described as follows: Beginning at a point on the southerly line of said Lot 2 (said line being also the northerly line of Toledo Avenue, 66 feet wide), said point being South 61 Degrees 39 Minutes 47 Seconds West 116 feet from the southeasterly corner of said lot 2; thence along the easterly line of Livernois Avenue, 100 feet wide, North 28 Degrees West 61.89 feet to a point on the northerly line of said Lot 1, being

also the southerly line of the Michigan Central Railroad Right-of-Way; thence along said line North 39 Degrees 03 Minutes 57 Seconds East 21.72 feet to a point; thence along a line South 28 Degrees East 70.23 feet to a point on the southerly line of said Lot 2; thence along said line South 61 Degrees 30 Minutes 47 Seconds West 20 feet to the place of beginning, containing 1,321.25 square feet."

Copies of the correspondence exchanged between the writer and the C. N. Ray Corporation are attached for

your information.

I respectfully recommend that the Corporation Counsel be authorized to complete the purchase of the land above described, for the sum of \$1,-651.46. In addition to this purchase price, the City is to rebuild the sidewalk on the new line, without cost to the abutting property. This sidewalk is to be constructed of sufficient strength to permit of its use as a driveway entrance to the property.

The City will also, at the time of setting the new curb in front of the property, drop the same for a distance of approximately sixty-seven feet, in order to permit of the driveway en-

trance contemplated.

In excavating for the reconstruction of the sidewalk, the City will slope the embankment on the property of the C. N. Ray Corporation, to an angle of forty-five degrees, in order to prevent the washing of the adjacent land onto the sidewalk.
