To the Honorable, the Common Council:

Gentlemen—In accordance with your request, the City Plan Commission has prepared a plan for the opening of Erwin Avenue between Grinnell Avenue and Lynch Road.

The plan submitted herewith provides for an 86-foot street, the present width of French Road, and utilizes City property wherever possible. This means that only two parcels of privately owned land will be affected and we understand that one of the owners will deed the land required for the street widening. The plan as prepared by us also makes use of the existing half street, which has already been deeded north of Grinnell Avenue.

We believe that this plan can be accomplished at a very early date and it is the least expensive of all the plans we have studied. The plan meets with the approval of the City Engineers' Office and the Department of Public Works insofar as the airport is concerned.

All of the above is outlined on the attached blue print, plan No. 621-1A.
