"In the matter of extending the jurisdiction of the Board of County Road Commissioners of the County of Wayne, Michigan, over the certain road hereinafter described, it was moved by Commissioner Haggerty, supported by Commissioner Butler, that the Board of County Road Commissioners extend its jurisdiction over the following section of road heretofore laid out:

"Commencing at the intersection of Caniff Avenue with Mound Avenue and proceeding thence north along Mound Avenue to its intersection with Seven Mile Road. Said road to be known hereafter as Mound Road.

"Vote on the motion resulted as follows: Ayes, Commissioners Hines, Haggerty and Butler; nays, none. Whereupon it was ordered that the above described road be hereafter a County Road under the jurisdiction of the Board of County Road Commissioners of the County of Wayne, Michigan."

"In the matter of extending the jurisdiction of the Board of County Road Commissioners, for the County of Wayne, Michigan, over the certain section of road hereinafter described, it was moved by Commissioner Haggerty, and supported by Commissioner Butler, that the Board of County Road Commissioners extend its jurisdiction over the following section of road heretofore laid out:

"Beginning at the northeast corner of Section 28, Town 1 south, Range 10 east; thence north 88 degrees 48' 45" west, 2,685.38 feet; thence south 89 degrees 26' 50" west, 2,432.29 feet to a point on the north line of said section 28, lying 200 feet from the northwest corner of said Section 28. A total distance of 5,117.67 feet or 0.9688 miles. Said road to be known hereafter as Schoolcraft Road.

"Vote on the motion resulted as follows: Ayes, Commissioners Hines, Haggerty and Butler; Nays, None. Whereupon it was ordered that the above described road be hereafter a County Road under the jurisdiction of the Board of County Road Commissioners of the County of Wayne, Michigan."
