faith and credit bonds or other evidence of indebtedness of the city of Detroit, by mortgage bonds secured only upon the property and revenues on said system, and by such moneys derived from other sources as may be available in the Rapid Transit fund, and by special assessments levied on property benefited: Provided, however, the Common Council shall determine that sufficient benefit has accrued to private property, as to render it reasonable to levy such assessments and further provided, that in levying the special assessments herein authorized, if any property in the Rapid Transit special assessment district has been assessed in the ten year period subsequent to July 1st, 1924 for street openings or widenings, the Rapid Transit special assessment on said property shall be credited with the amount levied on said property in any street opening or widening assess-

ment during said ten year period."
We accept and adopt the above as a substitute for original paragraph four and ask that it be adopted as a part of the plan.
