Gentlemen—The City Plan Commission is in receipt of a communication from Perry A. Fellows, City Engineer, calling attention to the condition of the north and south and east and west alley in the block ly-ing south of Grand River Avenue, between Monica and Stoepel Avenues.
A study shows that no adequate

outlet exists at the present time for the lots fronting on both Stoepel and Monica Avenues. Further study showed that if this alley were widedend, an adequate outlet would exist

for practically every lot in the block. Consideration has been given to the matter of opening the east and west alley, but we are of the opinion that this is not necessary, and that if such a project is carried out, it will seriously affect a large building site which has a particular value because of its depth, and that the cost which may be incurred will be greater than the benefits to be received. We have communicated with the owners of the property affected, and they have shown a marked willingness to co-operate with the City. We are enclosing a deed which they have submitted providing for the widening of the north and south alley, which will permit adequate ingress and egress for all of the lots on Monica and Stoepel Avenues, and for a majority of the lots on Grand River Avenue.

The City Plan Commission recommends that this deed be accepted, and that further consideration of the opening of the east and west alley be indefinitely postponed.
