To the Honorable, the Common Council:

Gentlemen-The work in connection with the Ambulance Service of the Department of Public Welfare has increased to such an extent that we find it necessary to apply to your Honorable Body for additional help so that this service may be operated to a fuller extent.

We now have four ambulances and five crews of two men each. We have to provide continuous day and night service including Sundays and holi-days and on a forty-eight hour week basis for the crews. The best possible schedule we can work out with the present number of crews permits us to operate only two ambulances dur-ing the busiest hours of the day and night, resulting in many complaints from physicians and patients and frequently necessitating our calling on private ambulance firms to care for the overflow.

By supplementing the present service with two additional crews we will be able to operate three ambulances on week days from 8 a. m. to midnight, two ambulances for the same period on Sundays and one ambulance from midnight to 8 a. m.

every day. The Public Welfare Commission, therefore, respectfully requests that your Honorable Body provide for the remainder of the current fiscal year the sum of \$3,710.00, effective December 1st next, and direct the City Controller to credit same to Welfare Account No. 6B, Ambulance Service as follows:
