From the City Plan Commission June 8, 1929.

To the Honorable, the Common Council:

Gentlemen — In accordance with your request, the City Plan Commission has considered the proposal to widen Woodward Avenue between the Six Mile Road and the Eight Mile Road to a width of approximately 130 feet.

This matter was covered in a very thorough report submitted to your Honorable Body in December 1927 by the City Plan Commission, and the Rapid Transit Commission. A

copy of that report is enclosed, here-with.

As you know, the matter of the widening of Woodward Avenue to a width of 204 feet has been given a great deal of consideration by various public bodies during the last five years. This widening has been urged by the Board of County Road Commissioners of Oakland County and Counties to the north, as well as by a number of other bodies interested in traffic in the Detroit region.

A traffic count on Woodward Avenue north of the Eight Mile Road during 1928 showed 60,000 vehicles per day on that street, and these vehicles should be given an opportunity to spread out on the Eight Mile Road, the Seven Mile Road and the Six Mile Road. It is therefore important that no bottle-neck be created in this street between the Eight Mile Road and the Six Mile Road. We are of the opinion that very little advantage will be gained through the widening of Woodward Avenue to a width of 130 feet. We, therefore, wish to advise that the City Plan Commission re-affirms its previous action, and recommends that your Honorable Body proceed with the widening of this street at a width of 204 feet, as already ordered.

Resolved, That in connection with the widening of said Woodward avenue the Board of County Road Commissioners be and is hereby requested to consider the matter of separating the grades at the intersection of said street with the Six Mile and Seven Mile Roads.
