To the Honorable, the Common Council:

Gentlemen—I am enclosing herewith a resolution providing for the acceptance of certain streets and alleys in Ridgfield Subdivision No. 1. The resolution provides for the cancellation of the City taxes for 1929 and 1930 on the strip of land known as St. Martins Avenue and the cancellation of the special assessment tax for the paving of Pembroke against the properties dedicated. The acceptance of the streets is made conditional upon the dedication of a ten foot strip of property if and when Pembroke Avenue is widened in accordance with the terms of the agreement filed by Vernon C. Fry. The deeds covering the property dedicated for such streets and alleys are enclosed herewith, together with the agreement signed by Mr. Fry. The descriptions have been approved by Mr. Eck, City Engineer.

Resolved, That the City of Detroit, a Municipal Corporation hereby accepts the following streets and alleys as described below, to-wit:

ST. MARTINS AVENUE FROM LIVERNOIS AVENUE TO ALLEY FIRST WEST OF CRUDDER AVENUE. A certain parcel of land in the North $\frac{1}{2}$ of the Southeast $\frac{1}{4}$ of Section 4, T. 1 S., R. 11 East, City of Detroit, Wayne County, Michigan, described as follows: Beginning at a point which is distant 636.67 feet measured along the east line of said Section 4 and South $89^{\circ} 30' 30''$ West 60 feet from the east $\frac{1}{4}$ post of said
