To the Honorable, the Common Council:

Gentlemen—The Committee on City Finances met today to discuss the financial problems which are now facing the Mayor and your Body. These problems appear to be the following:

I. PUBLIC IMPROVEMENT PROGRAM.

- (a) Long Term
- (b) Unemployment Relief

II. BUDGET 1931-1932

III. DEFICIT OF ABOUT \$22,000,-000.00.

IV. SPECIAL ASSESSMENT TAX BURDEN

Obviously, a committee of citizens such as ours cannot put together in detail either a long term improvement program or a city budget. We have not the intimate knowledge of the details in which the city government engages, to handle such a task properly. That duty and responsibility belongs to the Mayor and Common Council, aided by department heads, commissions, and boards such as the Board of Education, elected and appointed for that purpose. Such study and recommendations as we can make must necessarily be mostly of the plans or principles upon which these things may be done. It is true, however, that the civic organizations represented on our Committee have in their membership committees which have studied budgets and made suggestions in detail with respect thereto, and they will be available now as heretofore.

The underlying facts which should control are that this is a period of business depression; that under our present unbalanced system of taxation, four-fifths of the burden of paying the cost of government is upon real estate; that real estate is already suffering from the severest depression it has known for years; and that there is an absolute and positive limit to its ability to pay taxes, and therefore an end in sight to the income for the City which can be derived from it. Alarming increase of delinquent taxes is the proof of this.

In other words, there is now an emergency amounting almost to a financial crisis facing the city, and its financial program therefore must be framed to prevent that and to enable the city government to perform efficiently its most important functions of protection of life, safety of person and property, and conservation of health. All other activities must await better times and more favoring conditions.
