Avenue, north of the Detroit Terminal Railroad. On December 29, 1925, your Honorable Body granted the petition but the resolution was never prepared for condemnation.

April 16, 1929, we were directed by your Honorable Body to study the matter and hold a hearing with the

interested property owners.

The estimated cost of this improvement figured from the assessed val-

uation is \$66,000.

A hearing was held on February 14, 1930, with the owners in the proposed tentative assessment district as recommended by the Board of Assessors.

For your information, we wish to

offer the following:

1—The proposed assessment district includes all the property south of Bourke Avenue on the north, north of the Detroit Terminal Railroad on the south, east of Livernois Avenue on the west and alley first east of Fairfield Avenue on the east.

2—The owners of six parcels of property, paying an estimated tax of \$1,508.36, have expressed a desire to

have the street opened.

3—The owners of sixty-three parcels of property, paying an estimated tax of \$20,930.48, stated that they do

not want the street opened.

4—Of the forty owners that signed the petition requesting the street, five of the petitioners' property would be taken by condemnation, eleven of the petitioners did not own lots in the proposed assessment district, their property being north of Bourke Avenue, and fifteen of the petitioners voted against the opening at the hearing.

Therefore, this Commission recommends that the petition be denied and all previous action be rescinded inasmuch as 91 per cent of the interested owners in the proposed assessment district are not in favor of the opening.
