The necessary amount of landscaping was done during the year. the present we are confining most of the landscaping to the permanent exhibits and their immediate neighborhood and to permanent walks, as it is inadvisable, except when absolutely necessary to spend money for such landscaping as might be only of a temporary character.

The water system at the park, because of large exhibits, such as the African swamp, lion, rhinoceros, hippopotamus, exhibits, etc., has become inadequate and therefore the Commission has just recently secured proposals through the City Purchasing Department for a permanent water system from outside contractors, and consequently a contract was let at a very reasonable figure for approximately 10,400 lineal feet of eight inch cast iron water pipe, which will be The hylaid in the early spring. drants necessary for this system will be furnished by the Detroit Fire Department, and the rest of the material will be furnished by the City Water Beard. The hearty co-opeartion of the various City Departments has made it possible for us to have this work done for much less than the original estimated cost.

Bronze tablets showing the names of the donors of our various animals have been, and will continue to be, placed on all completed exhibits.

A temporary building has been erected at the rear of the park for general offices, stock room, tool crib, etc. The combining of these divisions under one roof will, we expect, make for greater efficiency and economy of operation .

In addition to the water system above noted, 2,200 feet of sewer and 1,150 feet of drains were laid in the park during the year. Great economy in this work was effected by virtue of the efficiency of our new combined shovel, crane, dragline and bucket

that was purchased in the early spring.

It was necessary to construct several temporary exhibits during the year to house the giraffes, kodiak bear cubs, camels, dromedaries, etc. cost of these was not great, and some have been, and the remainder will be, replaced by permanent shelters.

As we expected, the Refectory Department operated by the Commission at the park during the season has been even more successful than the year before. The total receipts were the total expenditures \$56,542.20; were \$41,237.57, leaving a net profit of \$15,312.63.

The total appropriations to December 31, 1929, from the special tax for the Detroit Zoological Park were \$2,-060,292.43; the total expenditures for the same period, including maintenance and operation, were \$1,966,119.12. leaving a balance on hand as of January 1, 1930 (also including the maintenance and operation funds) of \$4,-173.31.

The Commission desires to express its renewed appreciation of the loyalty, industry and marked ability of its Director, Mr. John T. Millen. He deserves and has our entire confidence.

We also wish to thank the various city departments with which it was necessary to come in contact during the past year for their whole-hearted and unstinted co-operation, without which it is doubtful whether the progress made could have been accomplished, and we sincerely hope and believe that this co-operation may and will continue in the years to come.
