Whereas the Board of Street Railway Commissioners, by and through its President and Secretary, pursuant to a resolution passed by said Board at a regular meeting held on July 16, 1929, executed a deed of the private rights of way of the Department of Street Railways, in said deed particularly described, to the City of Detroit,

a municipal corporation, dated February 28, 1930; and

Whereas, said deed was tendered this body for acceptance for the City of Detroit, a municipal corporation, in a communication to this body on February 27, 1930.
