AN ORDINANCE to amend Section 26, Chapter 177, of the Compiled Ordinances of the City of Detroit, and entitled "An Ordinance providing for the conduct and regulation of parks and boulevards in the City of Detroit, and to repeal all prior ordinances or parts of ordinances in conflict herewith."

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF DETROIT:

Section 1. That Section 26, 2 Chapter 177, of "An Ordinance 3 providing for the conduct and 4 regulation of parks and boulevards in the City of Detroit, and 5 6 to repeal all prior ordinances or 7 parts of ordinances in conflict 8 herewith" be, and the same is here- 9 by amended to read as follows:

Sec. 26-a. No person, firm or 2 corporation shall operate or cause 3 to be operated upon or within any 4 park or boulevard any motor truck, 5 as that term is or may be de- 6 fined by the Michigan motor ve- 7 hicle law or any other vehicle used 8 for the hauling or distribution of 9 merchandise, freight or material, 10 except that newspaper delivery 11 trucks of not over two (2) tons 12 burthen may be permitted upon 13 Lafayette Boulevard, between 14 Griswold Street and Grand Boule- 15 vard.

Read twice by title, ordered printed, and laid on the table.
