Gentlemen-It has been brought to our attention that Woodmere Avenue running north from Vernor Highway along Baby Creek Park has been paved to allow for a 66 foot street although the record width of this street is only 25 feet. This pavement has been laid upon what is now park property.

In order that the records in the Engineer's office may be corrected it will be necessary for your Honorable Body to pass a resolution setting aside a portion of Baby Creek Park for street purposes. This matter has been taken up with the City Plan Commission and they recommend that Woodmere Avenue running north from Vernor Highway be 86 feet wide and that Richard Avenue from Woodmere Avenue to the southerly line of the park be 66 feet wide. The portion to be set aside being shown in yellow on the attached blue-print.

The property to be set aside for street purposes is described as fol-
