All bonds purchased under the provisions of this section or redeemed prior to maturity, shall be cancelled forthwith. All bonds issued under the provi-

sions of this resolution shall be payable at the office of the City Treasurer in the City of Detroit or at the Current Official bank of the City of Detroit in the City of New York, New York, at the option of the holder.

All bonds issued hereunder shall be subject to the opinion as to their validity by Messrs. Thomson, Wood & Hoffman, Attorneys-at-Law, New
