This will acknowledge your telegram transmitting the Resolution adopted by your Detroit Common Council in opposition to the ratification of the pending British Tax Exemption Treaty. I am very glad to have this expression of official opin-ion from the Detroit Council sustain-ing Mayor Jeffries' powerful brief upon the same subject. I shall present your Resolutions on the Floor of the Senate and have them referred to the Senate Foreign Relations Committee.

I am sure you are fully advised of my own position. I have fought this measure from start to finish and I shall continue to do so. Since I succeeded in stripping the secrecy from it there has been an accumulating demonstration of opposition across the country and I feel reasonably that the Treaty will not be sure ratified.
