Dear Sir-With the receipt from the State of Wayne County's share of the automobile weight and gasoline tax revenues for the year 1942, the amounts due the cities and villages have been determined as shown by the enclosed statement. From this statement you will note that the share of the City of Detroit has been computed to be \$3,501,441.27.

The distribution is made pursuant to Section 34 of Act. No. 302 of the Michigan Public Acts of 1915 and Section 19 of Act. No. 150 of the Michigan Public Acts of 1927, both as amended to date. These acts, as amended by Public Acts Nos. 256 and 257 of 1941, provide that the moneys returned to incorporated cities and villages shall be used for Detroit dedicating land for street
