This Power of Attorney in no way changes the original plan. It only eliminates anyone but the City Treasurer from one but the City handling the checks.

The Power of Attorney cannot be-me effective until approved by your Honorable Body and I hope that

you may see fit to do so.

I have taken the liberty of getting the approval of Mr. Krause, the Corporation Counsel and Mr. Cobo, the City Treasurer.
