Council: Gentlemen—Attached herewith is a statement of the comparative expenditures for the seven months (July through January) of the fiscal years 1943-44 and 1944-45.

The general funds budgeted expenditures show a gross increase of \$2,108,000 over 1943-1944. Eliminating the increase of \$714.000 in investment expenditures, the effective increase is \$1,394,000.

Operation and maintenance expenditures increased \$1,484,000, pension

expenditures \$91,000 and capital expenditures \$155,000. These increases have been offset by a decrease in interest expenditures of \$336,000 resulting in the net increase of \$1,394,-000.

Relative to the operation and mainexpenditures increase of tenance \$1.484,000, the effective increase approximately \$500,000 less or \$984,-000. This is due to the fact that three bi-weekly wage rolls were charged in the month of January, 1945, as compared to two charges in January of 1944.
